President's Perspective by Dr. Lisa M. Orick-Martinez

Each president of the International Listening Association is entrusted with helping to run the organization and to promote the ILA. As each president before me, I don't take this responsibility lightly.

During my ascension to the presidency, my biggest fear was being the president no one remembered. I feared I would not do anything outstanding or remarkable for our organization or for listening, in general.

I remember sitting in the beautiful German castle last year at the banquet, seeing the other members there and the guests, and telling my family, "What the heck am I doing? I'm way out of my league!"

But I now realize no one person does anything

alone, and neither does the president of the International Listening Association. I am honored to be surrounded by the members of the Board, by people passionate about both the ILA and listening in all of its contexts.

With this group of incredible people working with me, I have decided to take to heart the words of a wise and wonderful person, who wrote me the following message:

"I trust the hallmark of your year as President of the ILA will be based on a 'Strategy of Common Sense'."

Common sense suggests the ILA holds uncommon opportunity to impact the advancement of listening as the most neglected of the most important issues of our time—communication.

Common sense suggests we need to dramatically grow our membership numbers and to increase the diversity of our membership.

Common sense suggests we need to find the members who are willing and able to roll up their sleeves and continue to work for the good of the organization.

As the board and I make decisions that effect the organization, we need to consider the following things.

First, does the decision serve the ILA Vision and Mission Statement; and second, does the decision contribute to the fiscal and financial well being of the Association? Our organization is in danger of disappearing. We have financial challenges.

What Did Newcomers Think? By Laura Janusik, 1st Vice President Elect

When I attended my first ILA conference in 1999, I was amazed at how many people truly wanted to listen! They asked me questions, and they seemed genuinely interested in my responses. We often found common ground quickly, and I've formed some great friendships with these individuals over the years.

Helping newcomers feel welcome is something that ILA members do well. From the newcomer "Meet and Greet" to the other identifying ways we have of knowing, many of us seek them out and embrace them in our efforts to spread the news about listening around the world!

ILA members seemed to have kept their ability to welcome newcomers again this past March in Portland, Maine. On Saturday evening, I approached **Bjørn Stillion Southard**, graduate student at the *University of Maryland at College Park*, as well as a newcomer to the ILA conventions, and asked him how his experience was. It's important to note that Bjørn is a 19th Century American Public Address scholar, and he is active in a number of associations.

Bjørn indicated that he was both amazed and pleased. Amazed because he heard that conferences that embrace different ideas in a non-competitive way existed, yet he was skeptical that he would ever find one. Pleased that such a place did exist, and that he found it early in his career.

Arnie Katz, licensed massage therapist and facilitator of healing, was both presenter

and participant. The owner of two Boston-based companies (*Golden Hands Massage Therapy* and *Katz & Dogz*), Arnie came based on encouragement of his longtime friend and colleague, Jennie Grau.

Arnie said, "I really had no idea what to expect other than having the usual excitement and nervousness about being in a new situation and meeting new people. I am delighted to say that I felt welcomed with open arms and with enthusiasm. I found people to be very friendly and very committed to listening well and engaging more deeply than at other conferences I have attended."

Arnie added, "By far, the best part of the conference for me was the people, and the camaraderie, and the love and respect people genuinely seem to have for one another."

Gina Castle is finishing her master's studies at the *University of Florida in Orlando*. I met Gina at last year's NCA conference. I saw that she and her advisor, Harry Weger, were doing some fascinating listening research. I invited Gina and Harry to the ILA conference, but only Gina was able to attend.

As you might imagine, she was a little nervous at first, but quickly found her comfort zone. Gina said, "When I came to ILA this March, I was expecting the conference, although it was smaller, to have more of an NCA feel. However, I was pleasantly surprised to find that the atmosphere was much more inviting and less intimidating than I imagined.

Sometimes big conferences can be overwhelming because not adequate time is available to develop personal friendships with colleagues throughout the world. Thus, it can be intimidating to be one of 5,000 people in a room.

My experience at ILA as a first time member was a joy. I was able to have good conversations with people from all over the nation, over every meal. Not only that, but ILA members were engaging.

Members listened to one another when they spoke, and everyone seemed to care about one another's well being.

I really enjoyed the conference. I felt spurred on to come home to do research and write papers. I had a wonderful time at ILA, and I plan to continue to come to the convention in the future."

As some of you were aware, we had a very prestigious and prolific scholar attending his first ILA conference. **Molefi Kete Asante** is the most published African-American scholar, with 65 books and over 300 articles in print. You can learn more about him at <http://www.asante.net>.

As he was working on yet another deadline, he did not have much time to comment; but he said it best succinctly: "The conference was wonderful!"

Finally, **Tesa Lane** from Central New Mexico Community College summed up her newcomer's perspective best with the following statement:

I recently had a student dealing with issues with our school. She was frustrated because she was passed around from department to department. I sat and just listened to her. I listened to how frustrated she was.

After a bit she stopped and said: "That's all I needed, a good listening to."

She got in touch with me a few days later to tell me that she was feeling better, and her frustration level was much reduced. She thanked me for "just listening" and said it made a difference to her.

Imagine what power each and every one of us holds by being able to "just" listen. How might things change in our circle of influence?

It is with this in mind that I bring to you some challenges. I challenge each and every ILA member to get at least two people involved in the ILA—have them join our wonderful organization and encourage them with your passion to get involved on committees!

Then I further challenge you to bring one person with you to your next regional function and two to the next convention.

You made a commitment when you joined the ILA to be part of THE premiere listening organization in the world; now prove it. Let's use our common sense to get the word out

about the importance of listening, use our common sense to get businesses to see how important listening is to their bottom line and persuade them to join and support the ILA, use our common sense to get educators to demand time to teach students to listen.

I also challenge you to bring financial resources into the ILA by doing two simple things.

Book Review By Susan Timm

F Means Floundering. A Guide to Becoming An Efficient and Effective Student (iUniverse, 2007)

F Means Floundering by Charles Swanson, Ed.D. provides practical advice to students just starting their degrees and those struggling with earning a college education so that they can become more efficient and effective students. What makes this study-skills text different than most is its emphasis on effective listening as a key to academic success. Plus, the focus is on learning as opposed to simply giving "seat time" to one's classes.

Written in easy-to-understand terms, Swanson shares his own experiences as a stressed student; he tells students what to do to increase their learning. After reading this book, as an "introduction to college" faculty, I believe F Means Floundering earns an "A" in Student Success!

NOW HEAR THIS! 2008 Listener of the Year Announced!

Listener of the Year isn't one person, but a group of people who work with *ChildLine* and *BT* (formerly *British Telecom*). *ChildLine* benefits from BT's fundraising and social marketing campaign entitled "Am I Listening?" that promotes listening to children and young people. This campaign is what first caught the ears of the members of the ILA Awards Committee.

The listening that ChildLine and BT are involved in liter-

ally saves lives. As its website explains, ChildLine is UK's free, 24-hour helpline for children in distress or danger. Almost 1,400 trained volunteers answer around 2,500 calls daily from children and young people looking for comfort, advice, and protection.

BT is a founding partner and has supported ChildLine since 1986. BT (then British Telecom) served as part of the team of experts advising ChildWatch, the program,

which launched ChildLine. The company has since donated office space, telephones, and financial support, as well as providing a simple and memorable free phone number for children to call.

Two individuals (Beth Courtier and Justin McKeown) came from the United Kingdom to receive their awards. And, Justin made the decision to become a lifetime member of the ILA. Welcome to the ILA, Justin!

UNI's Beall Receives Top Listening Recognition

Melissa Beall, a *University of Northern Iowa* (UNI) communication studies professor, was honoured twice by receiving the **Outstanding Teacher of Listening** and by being inducted into the **Listening Hall of Fame**.

Anyone who knows Melissa can attest to her deserving these awards. Melissa was profiled in the last [Listening](#)

[Post](#) as a "**Listening Legend**."

Beall earned a doctorate in communication education and communication theory, a master's degree in speech and dramatic arts, and also a bachelor's degree in English, speech and dramatic arts, all from the University of Nebraska-Lincoln.

A full professor since 1994, Beall has served at UNI for 18 years, including serving as thesis adviser for 20 completed master's degrees.

Because of her listening accomplishments, Melissa received a certificate of recognition signed by the Iowa Governor, Lt. Governor, and the local House Representative. Way to go, Melissa!

Author Linda Eve Diamond Receives Two Listening Awards

Author Linda Eve Diamond, of Dania, Florida, was honored with two listening awards: **The President's Award** and **Listening in the Business Sector Award**.

The **President's Award** was presented by outgoing president, Dr. Margarete Imhof of Frankfurt, Germany.

Linda received the award for her creative and successful efforts to bring knowledge and understanding of listening to a larger audience and for her role as the [Listening Post](#) editor from 2006-2008.

Imhof reiterated her support and appreciation of Diamond's latest book, *Rule #1: Stop Talking! A Guide to Listening* (Listeners Press, 2007), which she called "an excellent example of how academic knowledge can be re-packaged for the general interest without being thinned out or oversimplified."

Linda received the **Listening in the Business Sector Award** for her numerous efforts to further listening awareness. Three of her business books stress the importance of listening as

essential for motivation and team building; and her latest book, *Rule #1*, is devoted entirely to listening. Linda's creation of a strong online presence dedicated to listening at [Listeners Unite](#) was also recognized.

The University of Maryland University College Earns Special Recognition

Over 2,250 students have completed instruction in listening, taught by a dozen professors in face-to-face classrooms, across interactive closed-circuit TV, April 10.

Summary Highlights of 2008 ILA Convention Business Meeting Minutes

Business Meeting Discussion—Continued

Search for Web-Editor and re-design of the Website are top priorities. The Board has been working hard on redesigning the Website. Thus, we will have a new Website and a new Website Editor very soon. (Editor's Note: Susan Timm has agreed to take on the Web Editing position starting this summer as one of Melissa's colleagues has agreed to serve as the LP editor. Nan said that she would help with the Website. Currently Joyce is continuing to update the site. Thanks, Joyce!)

Margarete would like to see another online publication, possibly something similar to the *Listening Professional* or a publication for the education sector. In addition, we may want to put some "appetizers" on the home page to draw interest into the site. Communication Briefs is a journal that has good format we might use for our proposed online education and business journal.

Financial Budget (Refer to Budget on page 9.)

Nan took over as Executive Director in September. We carried over approximately \$5,000 from last year. We have approximately \$3,000 in a PayPal account for recent registrations. Following is a list of the expenses:

- Award costs are standard as previous years.
- The Board has awarded each committee \$500 to spend on their various efforts.
- Convention expenses are a good "guesstimate" of \$25,000, which hopefully will be more like \$20,000.
- Everything is on PayPal now, not Elan. The fees are about a wash, and it works better.
- Honorarium for Executive Director—same
- Insurance is a little different due to the ILA office being in a new state.
- *Printing*: some Listening Posts, other paperwork for Board members, etc.
- *Postage*: We still have to mail letters, some Listening Posts, and other items to the membership.
- *Site Selection*: Trips previous ED made to sites will not be done in the future.
- *Student Scholarships*: Wash, since funds from other sources are being collected.
- *ILA Store*: pens and luggage tags. The Boutique is now the ILA store. Nan probably will not order anything new for the store. We need more professional image and different products in the future.
- *Tax Preparation*: less than \$600 per year now.
- *Wild Apricot*: E-mail system that sends out blasts—prevents so many mailings and eliminate Costs for postage and printing.
- Journal costs are high, with \$6,000 last year and this year, which is a large amount of money that ILA has to pay. The Board is checking with *Taylor and Francis* to determine if we can generate two, not four journals, as we cannot afford paying for four journals a year. *Taylor and Francis* mails the journal, and the cost is about the same as the previous publisher. Since we do not advertise and we cannot even get enough submissions for two, we will be hard pressed to get enough articles for four editions. Thus, we may run into a deficit if forced to go with four issues.

We anticipate raising registration fees for the next convention and streamlining the registering process. We reached our room limit for this convention and will not have to pay for meeting rooms. Convention planners should negotiate tougher with costs. Board should find large sponsorships for the conventions.

Motion was moved and seconded to accept the financial report. Then a motion was made to appoint an ad hoc committee to look at the finances more closely and to make one new financial implementation a year. Shelia, Laurie, and Greg volunteered.

Membership Initiatives

Listening Regions is the most exciting plan in quite a while that will increase our membership. People join for the people; we are a family. Therefore, ILA needs to provide more listening opportunities for its people, especially for those who want to make connections but can't afford to attend the conventions.

People who pay membership fees and don't come to conventions usually don't stay as members. Regional events can cross boundaries, and regions will change as membership grows (Refer to page 2 for delineation of regions and their leaders). Regional leaders must live in their particular region; yet, events would not need to be for members only. In addition, using regions will accomplish the following:

- Increase the pipeline to leadership positions; regional leaders could later become Board members.
- Give a local welcome and other communiqués from regional leaders to renew and maintain membership.
- Provide a whole section on-line for people to easily find their regions as well as consultants, researchers, etc.
- Present one sponsored event per region each year.

2010 Site Selection

Several options were considered; however, we decided to go back to Albuquerque, New Mexico. Lisa (President 2008-2009) has college support from her president and from the students. Central New Mexico Community College (CNMCC) has committed to send 15 students to Milwaukee.

Election of New Officers

Nominees were announced by the Nominating Committee, which still needed one more member, so nominations were taken from the floor. A motion was made to accept the slate as is; a vote approved it. Editor's Note: The person who accepted the nomination from the floor had to reline the position after the convention ended due to other obligations. The president is will be announcing the Member at Large for Special Projects at a later date.

Bylaw and Constitution Changes Discussion (Continued)

Purpose and overview of Constitution changes:

- Constitution and Bylaws need to be separated to enable timely decisions, since Electronic Age allows Board to communicate and makes changes quickly.
- Constitution would always be controlled by the membership, and no changes are recommended.
- Bylaw changes, however, would come from the Board.

Review of two amendments:

1. Separate Bylaws and Constitution into two documents
2. Power issue—who has control? Bylaws changes would be Board's responsibility (committee duties, etc.); Constitution would be the membership's.

Much discussion resulted. In addition to the current method (at the current ILA yearly convention business meeting), we have the ability to have e-mail voting where members can still accept, reject, or abstain. A motion was made and seconded that in addition to the current procedure for voting on Bylaw changes identified in the Constitution, the following additional Bylaw revision procedure would be permitted: An e-mail blast or upon request of the Executive director, postal delivery, will be used to notify members of proposed Bylaw changes.

Motion was reworded for Constitution was passed: An e-mail or postal literature is sent to membership that includes the proposed motion (addendum or revision). Discussion will be open for 30 days; and on the 31st day, a second e-mail or postal mailing is sent to the membership for voting. Voting will be open for seven days, at which time it will close. For an addendum or revision to pass, 10 percent of the current active membership must vote to constitute a quorum, and 2/3 of those voting must affirm the motion to constitute a change. Voting options will include, "accept," "reject," "abstain," and "refer to the annual meeting".

Article II: Mission and Vision

A new mission and a vision statement were approved as follows:

New Mission: To advance the practice, teaching, and research of listening throughout the world.

Vision: To be the international leader of listening practices, teaching, and research.

It was almost exactly ten years ago, when I first attended an ILA convention. This was in Kansas City in March 1998. It was the beginning of a wonderful relationship, and now I am standing here as an almost past president of this organization. I am grateful for these past ten years of a rich professional and personal experience. During these past ten years, I have always felt encouraged and supported in my listening research and practice. When I first set out to do listening research, I did not find many others in my home country [Germany] who took listening research seriously. So I learned a lot about listening from colleagues and—as time went by—friends in the ILA.

Without the discussions and the exchange of ideas within ILA, both during and outside the conventions, I would not have been able to complete my research projects on listening. Nor would I have been able to translate the knowledge about listening into the classrooms of the teachers I work with, both in the teacher education program at my university and in the in-service teacher education. Now, there is a small, but I can also say, rather active listening community in Germany; and we see the interest in listening practice, research, and training growing.

What I find most important is that more and more people are beginning to recognize that listening has an impact on what we do and who we are in our professional and personal lives. We are confronted with listening as a challenge. The German philosopher Lichtenberg once said: What a blessing it would be if we were able to open and close our ears just as easily as we are able to open and close our eyes. To this day, we cannot accomplish this; and we need to accept that listening is a ubiquitous phenomenon that concerns all of us. This makes it even more surprising that listening as a scientific and reflective endeavour has been neglected for so long and that the history of listening research and reflective listening practice is still relatively young. I am proud, and I think you all can be that we are part of this organization that has promoted listening so successfully and that the awareness of the impact that listening has on social structures and interactions is rising.

Just recently, I received an email asking me if I was available for an interview on how the lack of listening skills might be a cause for the failing negotiations between the representatives of the public transport services and the trade unions. This is remarkable, because many other factors had been dug out and considered as causes for the negotiation disaster, which was topped by a big strike of public transportation facilities in Germany. After so many things have been said by so many people, in so many different ways, it is finally hitting home that it is not sufficient to talk and to present ideas. It is only when someone takes in the ideas that are expressed in speech, which means it is only when ideas find listeners, that the way in which

Proposed Changes to Student Membership

An amendment was passed unanimously to accept for voting by general membership, a change in the definition of student members to include all ages and to eliminate the time limit. We must vote via postal mail or at next year's convention.

CURRENT, ARTICLE III, Section 2B

B. Student. A temporary regular membership shall be available to persons who are enrolled as full-time students in an accredited institution of higher learning. Such membership shall be limited to a maximum of five years although the Executive Board may consider individual waivers for an extension of eligibility for student status. Acceptance of the application shall result in a fifty percent reduction in the annual dues set for a Regular Member.

PROPOSED CHANGES

B. Student. A temporary regular membership shall be available to persons who are enrolled as full-time students in an accredited institution of learning. Acceptance of the application shall result in a fifty percent reduction in the annual dues set for a Regular Member.

Proposed Changes to Lifetime Membership Dues

A motion was made that lifetime membership dues be held in perpetuity in an interest-bearing account, which will insure operating funds by allowing these funds to draw interest; and it locks into this amount for life.

This approach is similar to an endowment, where the original amount is never used but serves as solvency. The interest is used, if needed, during any periods of deficit.

This constitutional change has to be completed through the postal mail. If approved, this one will be added under ARTICLE VI – LIMITS, Section 4.

Listening Certification


We need to look for other avenues of money building, for instance, a certification program. The Board has been discussing certification, and it does need more planning.


