Memphis, March 1993:

A Four Dot Perspective

(Editor's Note: Traditionally the Listening Post prints letters by first time conference attendees of their impressions of the annual conference. Following is Marsha Berry's impression of the 14th annual conference which was held in Memphis March 4-6.)

Wednesday, March 3 - I presented myself at the registration desk and was greeted very warmly and handed my convention materials by the officials. With much interest we looked at my name tag. Theirs were plain whereas mine was adorned with four dots - red, blue, green, and yellow. These colorful dots drew many questions and comments from fellow convention participants including, "How come I didn't get as many dots?" and "What do all those dots mean?" The red dot indicated that I was a new ILA member, the blue dot meant this was my first ILA convention, the green dot showed I was a student member, and the yellow dot let those who were initiates of the color code know that I was an international member. I felt pretty conspicuous to say the least. If the function of the dots was to encourage introductions then the objective was certainly achieved.

I met many wonderful people during the convention and I still marvel at the degree of cordiality and collegi-

ality amongst ILA members. This support and open exchange of ideas was present at every session I attended and I was especially impressed with the levels of listening exhibited by the audiences. As another member remarked, "These people really know how to listen." So for four days we listened and shared ideas, research, and teaching strategies. The sessions I attended were informative and stimulating. However one does not attend conferences and conventions just for the exchange of ideas. Contact with fellow travelers is clearly an important function of such gatherings and the ILA Convention was no exception. We were provided with ample opportunities to meet with one another in informal settings and were also able to explore Memphis, the home of Graceland and Beale Street, together. Graceland is an icon of American culture. Whether or not Elvis figured(s?) as a significant influence in a person's life nevertheless, he is an important part of American post-war baby boom culture. Therefore a visit to Graceland becomes a pilgrimage to some and a visit to an historically significant landmark to others. I belong to the second category and I found the atmosphere of reverence surrounding Graceland to be fascinating. Next was a visit to the Peabody Hotel where a family of ducks stroll through a

lobby crowded with onlookers each evening. We were informed by an ILA member that the roof of the Peabody Hotel afforded an excellent view of Memphis so we decided to check this out. After several elevator rides amid much laughter, and a climb up several flights past some deadpan cleaners who grinned broadly at us on our way down, we established that the view from the roof was most probably spectacular if one could get up there, however, this was not possible due to the renovations being carried out on the upper floors of the Peabody Hotel. We lingered in the lobby sampling excellent Californian Chardonnay before going to Beale Street (which is indeed home of the blues) for dinner.


The next day (Saturday, March 6) was my presentation day and the final day of the convention. I was delighted with the reception of my paper I would like to echo the sentiments expressed frequently throughout the convention. "These people really know how to listen." I saw how much impact listening has and now I have experienced for myself the importance of being really listened to in a professional/academic context. I found the experience empowering and I look forward to the next time I can attend an ILA Convention.

President's Perspective

Our 14th convention has come and gone. Most of the attendees thought all went well-from the programs to the functions. Mose Vinson and the Vance Ensemble gave us a flavor of the musical South, to add to the barbecue and the catfish we sampled before the tour of Memphis. Sara Lewis challenged us to free the children from the culture of poverty. We enjoyed renewing old friendships and making new ones. President Clinton was named Listener of the Year, and Belle Ruth Witkin was inducted in the ILA Hall of Fame. We had an international flavor of conventioneers with representatives from England, Sweden, the Netherlands, Canada, and Australia. In all, more than 150 attended.

We are at a crossroads to the future of ILA. Our membership is stable in terms of numbers- maybe too stable. We seem to have reached a critical mass; we grow and we decline, ending with about 400 people. Some have said that we have become a clone of the Speech Communication Association: others have indicated their dismay at not attracting/retaining business/consulting/training members. We increase our numbers in proximity to the convention; however, we must find a way to move to the next level. Please share any ideas you may have with Victoria Emmert, our second vice-president,

We enter the third and last year of the term of our Executive Director, Mary Wise. She has done a wonderful job with all of the things necessary to keep ILA on track and afloat. (I am sure a note of appreciation from you to her would be welcome.) We will need to find someone who is willing to assume the Executive Director's tasks. Any nominations and applications should be sent to me.



We are looking for ways to keep the cost of the convention registration stable. The final figures are not available yet, but ILA will absorb several thousand dollars of expenses which exceeded registration income. Sheila Bentley and Greg Enos will put their heads together and present their recommendations to the Board at the Fall meeting before we finalize the planning for next year's convention in Boston.

We are going to produce an ILA magazine with focus on listening applications. Margaret Fitch-Hauser has agreed to serve as editor for the first issue, with the goal of fall publication. We are testing the waters, so your submissions will be most welcome, especially if this is going to be an ongoing endeavor.

I am pleased and gratified to be serving as your president for this year. The legacy I have inherited is prodigious. I earnestly seek your participation and ideas for moving ILA to a position of greater prominence and vitality. As I work in your behalf, I remain guided by the poignant words of Nichols and Stevens:

"It seems that we shall eventually come to believe that the responsibility for effective oral communication must be equally shared by speakers and listeners. When this transpires, we shall have taken a long stride toward greater economy in learning, accelerated personal growth, and significantly deepened human understanding." I wish for all of us a productive, healthy, and personally fulfilling year. Let me hear from "all y'all" from time to time.

Just under 50% feel that we could cut the cost of the annual meeting by reducing food service.

Just over 50% feel that we could reduce the cost of the convention by meeting at less expensive hotels.



Pre-Conference Guidelines Approved

We have had varying degrees of success with our pre-conferences over the years. A lot of what needs to be done has fallen to the local arrangements chair by default; this has added substantial tasks to an already-full schedule. The following guidelines were approved by the board on March 7 in order that future coordinators of

pre-conferences will have adequate direction with which to proceed.

- 1. Any group interested in having a pre-conference meeting should send a proposal to the First Vice President by a date established by the 1st V-P (probably in late spring). The proposals should address the following minimum guidelines:
- · An explanation of the need for an intensive pre-conference meeting;
- · A description of the proposed activities (which should not be replicated during the convention)
- · A brief listing of the qualifications of the proposed presenters;
- · A request for an itemized budget, including costs and expenditures; and
- · A statement of the rationale for any fees required for attending.
- 2. When the pre-conference has been approved, a Pre-conference Coordinator will be appointed by the 1st V-P. (This person will likely be the proposal originator.) This individual will work through the 1st V-P and the local arrangements chair and have the following responsibilities:
- · To solicit, select, and communicate with the presenters;
- To prepare and distribute any promotional materials (locally and through the ILA office).
- To seek prior approval from the Executive Director for all expenditures not in the approved budget;
- · To arrange for space and equipment (through the local arrangements chair);
- · To oversee registration and the total pre-conference; and
- · To file a final report of expenditures and pre-conference success.
